#### ABIH NEWS This is a reprint of an email distributed to Diplomats from Lynn O'Donnell ABIH Executive Director

#### Dear Diplomat:

I am writing to alert you of changes in the ABIH Certification Maintenance (CM) program. All changes were previously announced but we are now approaching final implementation.

In 2010, we comprehensively evaluated the CM program to ensure that ABIH offers a top quartile program for our Diplomats. Improvement opportunities were identified and change projects were initiated. Some of the projects were completed in 2010 but most were implemented in the first quarter of 2011.

These changes impact every Diplomat so please take a few moments to review them. It's better to ensure clarity now than be surprised at the end of your CM cycle.

- 1. Fundamentals Points: The Fundamentals type of CM points was converted to IH type of CM points in the ABIH online database.
- 2. CM Approval Numbers: With a few exceptions, all Category 4 (Education) events must have a CM approval number to be listed on your CM worksheet.
- 3. Voluntary Surrender: The CIH (Retired) option has been replaced with a new program Voluntary Surrender which has improved options for re-certification.
- 4. Leave of Absence: A new Leave of Absence program was established to offer CM relief for up to two years.
- 5. Additional CM Cycle: A new CM cycle period of July 1st June 30th was established. Approximately half of the Diplomats were moved to the new cycle.
- 6. CM Worksheets: New CM Worksheets were published to accommodate the new cycle, automate the point calculations, and reduce input errors.
- 7. Late Worksheet Requirement: CM worksheets submitted more than 3 months after the CM cycle end date must be accompanied by all audit records.
- 8. Annual Fees Payment: Any Diplomat who does not pay their annual fees for 2 years will be decertified in the 3rd year.
- 9. Category 7 Changes: Many point earning opportunities in Category 7 have been moved to Category 4, where they can be counted toward the IH point minimums. Some items in Category 7 have been discontinued.
- 10. IH Ethics Cap: The IH Ethics type of points are now capped at five points per CM cycle.
- 11. Presentations Co-authors receive 0.5 point even though they are not the main speaker. Some restrictions apply.

Further information for all of the changes can be found on the CM portion of the ABIH web site, which you may also note has undergone a substantial reorganization and content addition. ## The Carolinas AI HA Section strongly encourages local universities and colleges to support sponsorship of a student local section.

#### **HERE'S HOW:**

#### Criteria to Form a Student Local Section

To be considered for sponsorship approval by a local section, the university/college at which the student section resides should meet the following criteria:

- The faculty advisor for the student local section must be a full member of AIHA or in the process of seeking full membership.
- The student local section must be sponsored by an AIHA local section.
- The bylaws of the student local section must be approved by the sponsoring AIHA local section and be consistent with and not in conflict with local section bylaw requirements as established by AIHA.
- The sponsoring AIHA local section must approve membership dues requirements for the student section.
- The university/college should be listed in the latest edition of Accredited Institutions of Postsecondary Education.
- The university/college's curriculum must be designed to adequately prepare students for the practice of industrial hygiene and/or a graduate level of study and should introduce the student to the tools, terminology, and professional services of the requisite interdisciplinary areas.
- The curriculum must have an adequate foundation in mathematics and basic sciences, the humanities and social sciences, industrial hygiene science, and industrial hygiene practice, as well as, preferably, a specialization in advanced industrial hygiene topics appropriate to the challenges presented by today's occupational health problems.
- The curriculum for a master's level IH program must demonstrate an intensive and comprehensive level of interdisciplinary instruction. Its content should include special project research and a thesis or internship. Special emphasis also may be placed in the development of research capability, management skills, and interdisciplinary and government relations knowledge.
- The majority of faculty members associated with the industrial hygiene program should have advanced degrees appropriate to their areas of expertise, extensive professional experience, and, preferably, certification by the American Board of Industrial Hygiene.

### PDC Information

#### **PDC Overview – Principle To Practice**

This course develops leaders that can use and teach the principles as a roadmap to build or enhance a culture that believes you can work injury-free. Participants will learn how to implement a rapid delivery improvement strategy for safety and share it with other people. The process requires focus and commitment from your leadership team. The instructor will teach participants to implement improvement strategies in three-week cycles. The practitioner will learn to lead teams to produce positive safety results. The strategies include common VPP principles and techniques to apply the principles. The rapid delivery process will also emphasize how important it is to have a core group of leaders that understand the urgency around safety and the value of building an injury-free environment.

The Principle To Practice Instructor will be David Lynn.

**DAVID G. LYNN, CSP,** is a Corporate Health, Safety, and Environmental Manager at the Fluor Corporation based in Greenville, South Carolina. David began his safety career in 1992 working for OSHA as a Compliance Officer. He conducted safety inspections that included audit, complaint and fatality investigations. David witnessed how the good and the bad managed health and safety across a variety of industries.

After 9 years of experience as an Environmental, Health, and Safety Manager with industry, David started work with Fluor in 2004 as a U.S. Regional Health, Safety, and Environmental (HSE) Manager based in Greenville, South Carolina. 


