# NOAA Releases Data on Air Quality in Gulf Region

The National Oceanic and Atmospheric Administration (www.NOAA.gov) released a data report on air quality measurements taken in the Deepwater Horizon oil spill area. The report summarizes the levels of almost 100 air pollutants measured by NOAA in June. Measure-

ments were taken 30 to 40 kilometers from shore and between 60 and 1,000 meters above sea level.

Although air pollutants typically found in most U.S. cities were discovered, the levels of certain hydrocarbons were

considerably higher than average polluted air. Particle matter downwind of the spill was equal to hydrocarbon concentrations in moderately polluted urban air; however, the particles were mostly organic material, which is not usually found in urban particulate matter. Near-shore measurements revealed pollution concentrations lower than those generally found in urban environments.

# 2011 Federal Budget - Aaron K. Trippler

### Speaking of the Budget

Here's where things stand on the budgets of interest to occupational health and safety:

OSHA – OSHA received approximately \$558 million in fiscal year 2010. President
Obama proposed a fiscal 2011 OSHA budget of \$574 million. As things now stand –
the House Appropriations Subcommittee has approved \$580 million for 2011; however
there is no breakdown of funding levels for specific programs until the full Committee
takes up the bill. In the Senate, the full Senate appropriations Committee has approved an OSHA budget
for 2011 in the amount of a little more than \$574 million, nearly identical to what the President proposed.
Outlook for OSHA – you can probably bet the Senate numbers will be closer to the actual dollars appropriated over what the House is considering.

<u>NIOSH</u> – President Obama proposed a 2011 NIOSH budget in the amount of \$269 million, up just a bit from 2010. This amount doesn't include Research Agenda dollars or the World Trade Center fund for first responders. No specific word yet on what the House or Senate might do with NIOSH funding but the final figure is likely to be very close to what has been proposed.

<u>MSHA</u> – The President proposed a small increase for MSHA to around \$360 million. However, the House subcommittee report approved \$368 million for MSHA. No word on what the Senate approved but MSHA is likely to receive somewhere between what the President proposed and what the House subcommittee

# HEXAVALENT CHROMIUM RULE EFFECTIVE 15 June:



Occupational exposures to hexavalent

OSHA's final rule requiring employers to notify their workers of all hexavalent chromium exposures went into effect June 15. The rule re-



vised a provision in OSHA's Hexavalent
Chromium standard that required workers
be notified only when they experienced
exposures exceeding established safe limits. Workers exposed to this toxic chemical
are at greater risk for lung cancer and
damage to the nose, throat, eyes, skin and
respiratory tract. https://www.osha.gov/

chromium can occur among workers handling pigments, spray paints and coatings.

# OSHA Rule Would Update Standards

On July 2, OSHA issued a proposed rule that would update or remove requirements within several outdated, repetitive or conflicting standards. The proposed rule, Standards Improvement Project (SIP)-III, is intended to maintain the relevance of OSHA standards and make it easier for employers to understand their regulatory obligations.

One of the updates that OSHA is proposing in SIP-III pertains to the definition of "potable water" in the Sanitation standard (1910.141). In this update, OSHA aims to sync its potable water definition with that of the current EPA clean water standard. OSHA also proposes the removal of a

provision in the Bloodborne Pathogens standard (1910.1030) that forces employers to provide hand dryers that release warm air. The elimination of this standard would permit the use of newer technologies that use room-temperature air.

The recommendations in the proposed rule were generated through OSHA's review of its standards and input from the public and the OSHA Office of Management and Budget. OSHA is seeking additional comments and recommendations from the public until Sept. 30, 2010. ### Morning Session:

Successful Strategies for Linking Safety with Risk Management & Insurance

In recent years, many safety programs have been involved in organizational realignments, shifting from stand -alone units to assimilation into comprehensive environmental health & safety programs. Such shifts compelled individuals to expand their professional knowledge base to better understand the roles of their new organizational colleagues. A current phenomenon is the creation of comprehensive institutional risk management programs which incorporate all health and safety functions, along with other institutional loss control and insurance activities In recognition of this trend, it is imperative that safety professionals become familiar with the risk management and insurance profession to ensure that issues are effectively communicated within the context of this new paradigm. This course will provide an overview of the risk management and insurance profession from the health and safety program perspective, specifically addressing (1) how an organization's loss exposures are identified and analyzed, (2) how risk management alternatives are evaluated, (3) how the most desirable option is selected, (4) the implementation of selected risk management techniques, and (5) the monitoring of effectiveness.

The collection of data describing Environmental Health & Safety (EH&S) program activities and outcomes has become a necessity to justify the continued allocation of necessary resources. The creation and assembly of activity and outcome metrics is particularly important for those programs not wishing to be subjected to judgment solely on injury reports and regulatory noncompliance. Although the information embodied in activity and outcome metrics can be very powerful, EH&S programs often do not display the information in manners that are compelling and lead to desired decision making. This shortcoming is likely due to an absence of formal training in the science and art of displaying safety data compellingly. In this session, the evolution of key EH&S program metrics will be recounted and discussed. Then, the basic tenants of effective data displays will be presented, drawing from the works of recognized experts in the field of information visualization. This information will be followed by a series of EH&S data display before and after "make overs" to demonstrate

the effectiveness of the techniques described..

Biographical information Dr. Robert Emery is Vice President for Safety, Health, Environment & Risk Management for The University of Texas Health Science Center at Houston and Associate Professor of Occupational Health at the University of Texas School of Public Health. Bob has over 28 years of experience in the field of health & safety and holds masters degrees in both health physics and environmental sciences, and a doctorate in occupational health. 


